

## Global Diversified Moderate Portfolio

### INVESTMENT STRATEGY:

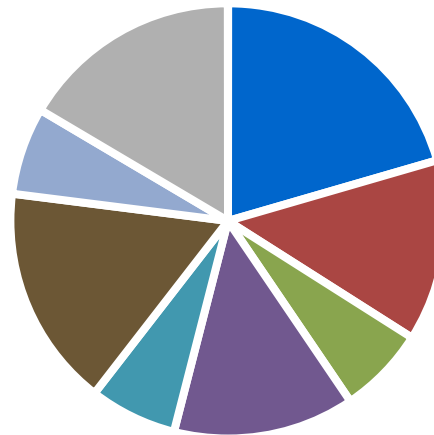
The Global Diversified Moderate Portfolio (GDMP) follows a moderate investment strategy. The objective of this model portfolio is to provide an equity-like return with less risk than that experienced by stock-only investors. This portfolio provides exposure to stocks, bonds, cash and diversifying assets. This investment portfolio is suitable for investors with a moderate risk tolerance and an investment horizon that is greater than five years.

### BENCHMARK:

60% - S&P 500 Index  
40% - Barclays Capital Aggregate Bond Index

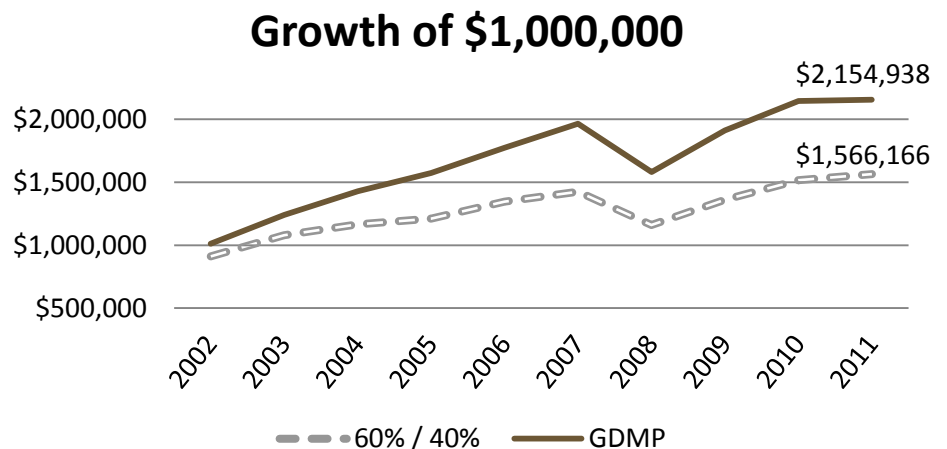
### ASSET ALLOCATION:

- Cash 16.5%

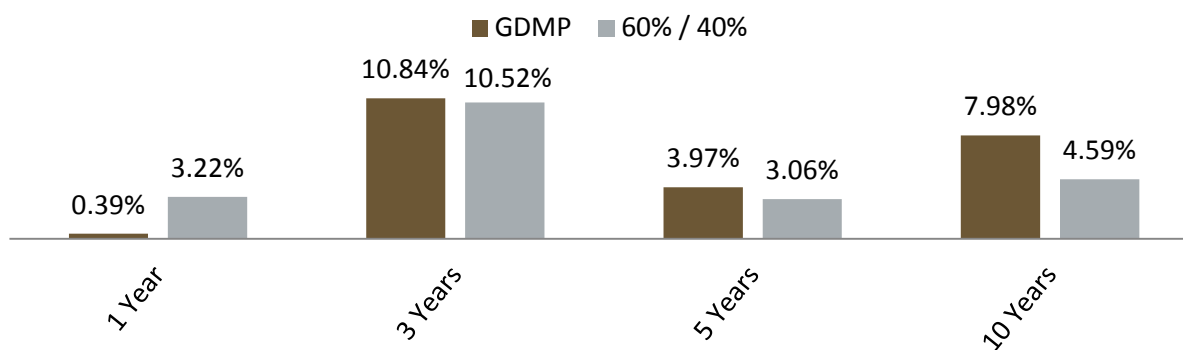

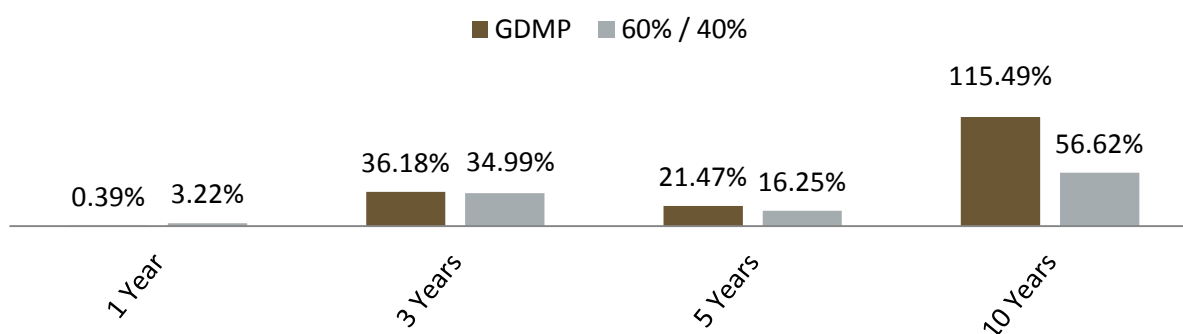


## Annualized Return
